- Players need to wear their t-shirts, athletic shorts or pants, and sneakers. Please bring a water bottle and a basketball if you have one.

# **Riverside School Basketball Agreement**

- 1. Players are expected to participate in all practices and games unless there is a valid reason to miss, as determined by the parent(s). Parents are to notify the coach or the school in advance when a player will miss a game.
- 2. Players are expected to cooperate fully and behave appropriately. Players who are uncooperative, use inappropriate language, or criticize other players, coaches or officials, will be subject to the following as determined by the coach: a warning, side-lining, and suspension from play.
- 3. Players are to arrive 10 minutes early for all games. Parents are to remain at the games or else make sure another parent is present who can be responsible for their player in case of an emergency.
- 4. Parents need to arrive 5 minutes early to pick up their child. Players are to be picked up at **3:15 p.m.** on practice days and are to be picked up immediately following games. Please do NOT ask your player to phone you when the practice/game is over. Coach must leave as soon as practices/games are completed.
- 5. Parents are not to drop off players before the Coach arrives or a designated parent assistant has arrived.
- 6. Starting line-ups for games will be determined by ability, enthusiasm, attendance, and adherence to the behavioral expectations of this agreement.
- 7. Every effort will be made to have all players participate in at least half the game. It is expected that players and parents will support this policy.
- 8. The registration form and payment is required for participation. Please make sure your child's forms are turned in by Tuesday, January 16. Please make checks payable to Riverside School.
